**Election of the Statutory Auditor (*revisor oficial de contas*) and its deputy (*suplente*) for the  
mandate 2017 – 2020**

Whereas:

- (a) Pursuant to articles 278(1), subparagraph a), and 413(1), subparagraph b), and (2) from the Portuguese Companies Codes, the supervision of Sociedade Comercial Orey Antunes, S.A. is carried out by a Supervisory Board and a Statutory Auditor, or a Statutory Auditor Company, which is not a member of that corporate body.
- (b) It is the Supervisory Board responsibility to, according to article 420(2), subparagraph b), propose to the General Meeting the appointment of a Statutory Auditor, naming a Statutory Auditor, or a Statutory Auditor Company, to be proposed to the General Meeting for election and to justify its preference, according to the terms of article 16 of Regulation EU no. 537/2014, of the European Parliament and of the Council, of 16 April 2014;
- (c) Pursuant to the abovementioned requirements, the Supervisory Board of Sociedade Comercial Orey Antunes, S.A., to be elected in the context of Item Four of the General Meeting's agenda and under the assumption and subject to the condition of being elected for the four-year period of 2017-2020, has selected a new Statutory Auditor to be

proposed to the General Meeting for the same four-year period of 2017-2020, hereby proposing to the Shareholders the election of the following entities:

- **KPMG & ASSOCIADOS - Sociedade de Revisores Oficiais de Contas, S.A.**, registered with the Statutory Auditor's Association (*Ordem de Revisores Oficiais de Contas*) under no. 189 and with the Portuguese Securities Market Commission (*CMVM*) under no. 20161489, to be represented by Paulo Alexandre Quintas Paixão, Statutory Auditor registered with the Statutory Auditor's Association under no. 1427 - **Statutory Auditor**.

- **Fernando Gustavo Duarte Antunes**, Statutory Auditor registered with the Statutory Auditor's Association under no. 1233 - **Deputy Statutory Auditor**.
